From the Editor-in-Chief



21<sup>st</sup> February is what many of us look forward to every year. Not just that it is declared by UNHRC as the **International Mother Language Day**, but more because its relevance has attained very high importance since Kashmiri Pandits lost the **Motherland** itself. It has assumed an emotional importance for the community. While living in the lap of our home in Kashmir, very scant attention was given to groom our progenies to enrich them in their mother tongue. Most would grow knowing the spoken word and not its historical richness.

Post-independence, Kashmir valley witnessed both geographic as well as demographic changes. With that came the new dispensation in the state of Jammu and Kashmir which, under the secular garb, brought in laws that made the minority Hindus in the valley ineligible for most of the opportunities. Thus, began a systematic outflux of Kashmiri Pandits from the valley. With this first post-Independence migration, the mother tongue became the victim of desertion by its own people. We seem to be genetically suffering from an acute inferiority complex when it comes to learning and propagating our mother language – Kashmiri. The result is that the post-Independence Kashmiris born outside Kashmir do not know their Mother Tongue.

The 1990 forced exile of the entire community from the valley accelerated the loss of Kashmiri language as this whole community followed the practice adopted by their predecessors over four decades ago. Today, the diaspora speaks the language of the place they have settled in, more fluently than the mother language.

It has the same significance as our rituals that we desperately struggle to follow in the hinterlands of our new abodes. We jostle with half syllables and pass the rickety language to our progeny as their mother language. In this backdrop, the Mother Language Day assumes great significance. Many linguists among us stepped forward to do a course correction. They have been systematically campaigning amongst the diaspora to make children learn Kashmiri. Every 21<sup>st</sup> February, we see programmes being organised by these linguist enthusiasts where young children perform in various ways in Kashmiri language.

While these initiatives are welcome, for bringing Kashmiri in our day to day conversation as the preferred language is still a far cry. For this, the parents of the new born have to pledge that they will introduce Kashmiri as the first spoken language to them. The child picks up from what we speak. And let that be Kashmiri. Let us take the pledge to give the mother tongue to our new generation and we will see in next decade our new children will take it forward and keep Kashmiri alive for us. This is food for thought.

#### WILL THIS CYCLE OF TARGETED KILLINGS EVER COME TO AN END!

Yet, another Kashmiri Hindu killed in a targeted manner by jehadis in Pulwama, Kashmir. Shri Sanjay Sharma, s/o Shri Kashinath Sharma, resident of Achan, Pulwama, was shot dead when he was on his way to the market with his wife to make some purchases. He was a guard at a local bank. Shri Sharma was killed by the ideology of Islamic Jihad, a new normal and unfortunately the local Kashmiri society has, for at least 35 years now, accepted this ideology as its dominant one. The movement to establish a "Nizam-e-Mustafa" (an Islamic sharia based state) has been ongoing in Kashmir for longer than 35 years, but at least since 1988, it has been carried out using the instrument of "Jihad", namely Islamic religious war upon anyone (usually Kafirs) who stand in the way of establishing a "Nizam-e-Mustafa".

Kashmir Jehad in 90's started with "Kashmir Banega Pakistan but without Kashmiri Pandits". Consequent to the ideology the narrative was built on a denial

mode that KP's were made to look like a thorn and an obstruction to the avowed design of Kashmir's Islamisation. It entered into every conceivable area of the society and thereafter these thirty-three years of their forced absence from the native land has given strength and teeth to this well designed narration. Thus the aborigines of Kashmir became a territory less community. Ever since KP's went through the painful ordeal of gradually eroding them from the socio-psychological memory of Kashmir. As victims of barbarism unleashed collectively on them by religious and political forces in equal measure by now is clear that there was an organised and well programmed coup against them but with a subtle politicoreligious patronage. What we see now is an offshoot of the process though started much earlier with it getting militarised in 90's for the purpose that stands achieved.

Painful killing of our community members at regular intervals has an uninterrupted continuity "kill one scare one thousand". The fact that such target killings against the residual Kashmiri Pandits have created a 'fear psychosis of greater magnitude within the Community' as they constitute an apathetic minority considering the population dynamics of the region, their vulnerability and fear, therefore, has intensified due to the tumultuous political environment and the persistent killings since 2019. The growing fear among Pandits is palpable. It raises a big question as to how the local Kashmiris can allow this to happen in their society and obviously they have no answers. However, the perception at the national level, based on the narrative built over more than three decades, depicts a consistent silence from local Kashmiris on such killings. This is because the fundamentals of the perception are essentially based on accommodation and appeasement of local populace, Blame gaming (alleged Jagmohan Theory behind the exodus of KP's) and discrediting pain trauma and sufferance of KP's. This is reflected in no or at the best a little outreach by local and national political leadership to the Pandit community. Resultantly they are nursing a sense of betrayal and rightfully so.

Considering how politics and terrorism has changed the region, several Pandit families and non-Muslims have consequently begun leaving the Valley. Although J&K has not witnessed major terrorist attacks on security establishments or convoys over the last few years but there have been targeted killings of religious minorities and of unarmed policemen. Most of these attacks have been carried out by "hybrid militants." It makes yet again the current ongoing witch-hunt against KP's a new, dangerous and challenging for them in Kashmir. While it is evident that these militants do not have the capacity or training to carry out attacks on wellguarded security establishments or armed personnel, they are a source of concern because they are able to kill civilians easily. Such killings have the potential to trigger an exodus of religious minorities from predominantly Muslim Kashmir. It is a fatal invasion of the evil forces from which we will probably never recover. As horrid as it is, what happened after the exodus of 90's is more significant: none of the villains were punished for their sins and atrocious acts.

It is simply the brutal climax that is mercilessly accomplished which is leading the Valley to stand on the cusp of paradigm change and things seem to be headed for an irreversible shift. The corrosion of human spirit and the ethical foundations which unfortunately it symbolises has other grievous consequences as well and the wellentrenched constituencies that it has created have eventually acquired frightening power on their own. Now, having morphed into disguised anti-KP forces of reckoning. Apart from Constitution and the Laws, any democracy and multiculturalism functions mostly on trust which is the most prized possession of politicians but Kashmir has been unfortunate in this regard as not even one member of the dynastic politics in vogue earned the trust of the minorities.

To make it a truly minority friendly place, the Government has to pay a far greater substantive and not superficial attention to the challenges that continue to take lives of KP's and other minorities with impunity. An opportunity has been created because of the decision to break the logjam by making sweeping reforms in the constitutional framework to end the region's special status and integrate Jammu and Kashmir into the national mainstream. Wasting this opportunity will be unfortunate because it will take years before another such chance is either created or presents itself.

# **General Secretary's Column**

The month of February-March has been very busy, as the AIKS team was hopping from one community event to another and also organizing its own flagship programmes like Mother Tongue Day scheduled for March 04, 2023. It felt pleasant to attend programmes after a long spell of cold winter. All in all, it has been a very busy month before the onset of full blown summer season.

# AIKS Team meets Chairman National Commission for Minorities (NCM):

Team AIKS led by its president Dr Ramesh Raina met with the NCM Chairman, Shri Iqbal Singh Lalpura. Besides the President the team included Senior VP, Padma Shri Prof Sudhir Sopory, VPs Dr Manorama Bakshi, Ms Alka Lahori and Shri Anoop Koul, Chairman Sampooran Kashmir. The meeting was arranged by Shri Anoop Koul. The agenda of the meeting was to apprise the Commission Chairman about the recent AIKS Ambala Declaration demanding for the creation of a legitimate minority space for the displaced Kashmiri Pandits in Kashmir. The President Dr Raina said that Kashmir today has been reduced to a monolithic society in the absence of minorities and a legitimate minority space for Kashmiri Pandits consistent with secular and multi-cultural ethos of the rest of the country----'By minority space, we mean that as the Aborigines, Kashmiri Pandits constitute a factorial importance in the socio-cultural construct of Kashmir. Therefore, the need for recognizing Kashmiri Pandits as a minority in Kashmir becomes all the more important'. Shri Anoop Koul, Chairman Sampooran Kashmir, said that, in the light of target killings and those people opting to stay and serve in Kashmir had become more vulnerable and there was no institutional mechanism like State Minority Commission on the lines of NCM to protect them. Prof Sudhir Sopory, Senior-VP–AIKS, described the situation in Kashmir as grave for non-Muslim minorities in general and PM Package Employees in particular and urged the Government to take strong and effective measures to grant minority status to contest such inimical forces and prevent another displacement from happening.

International mother tongue day was celebrated by Centre for Kashmiri Language Literature and Culture (CKLLC) of All India Kashmiri Samaj on 4<sup>th</sup> March, 2023 at the Kashyap Rishi Bhawan, Noida. Dr Ramesh Raina, President AIKS, while welcoming all the guests and participants who gathered from entire NCR region and even from Jammu, said that due to Shivratri the day could not be celebrated on its UN designated date of 21<sup>st</sup> February. He said this day is an important event for us at AIKS and we shall keep on our efforts to preserve and promote our mother tongue. He added that Vaakh, an AIKS publication in Kashmiri has turned out to be an important vehicle for the language promotion and that it gets readership from the traditional Kashmiri women folk because of whom its readership base has increased

considerably. He said we are pleased to designate the award being given to eminent personalities in the field of language and literature as Prof. Omkar Koul award. Prof. Koul was an eminent Linguist of the community and country whose contribution to the subject and to Kashmiri language and linguistics is phenomenal and well acclaimed. Dr.Roop Krishen Bhat, Chairman CKLLC spoke in detail about the origin and importance of International mother tongue day. He said that CKLLC was established within the All India Kashmiri Samaj to work for preservation and promotion of Kashmiri language and culture and to make available the Kashmiri learning and reading materials in Devanagri script.

On this occasion an audio course in Kashmiri conceived, written and developed by Dr. Roop Krishen Bhat was also formally launched on YouTube. Sh. Omkar Nath Shabnam was presented the Prof Omkar Koul award by Prof. Sudhir K sopory, an eminent scientist, former VC JNU and vice President of AIKS—(see full report).

#### AIKS Team attends Shuhul-Taaph:



# **In Search of Minority Space**

Mala Conclave of the All India Kashmiri Samaj (AIKS), held in January, concluded with the adoption of a statement called Ambala Declaration (AD), flagging quite a number of issues that beset the Internally Displaced Pandits. Attention of powers that be has been drawn to these issues suggesting, at the same time, some measures that could be employed to find a way out for safe, secured and dignified return of the IDPs to their roots, in Kashmir.

While not belittling the importance of other issues raised, the AD places a great deal of vehemence on a point which the declaration describes as "Reclaiming the Legitimate Minority space of KPs in Kashmir." The matter has been dealt with elaborately and compelling reasons in Annexure -1. To hammer down the point, appropriate reference has been made to history, geography of the area and aborigines thousands of years compact with the social, spiritual and political ambience of the Valley. "Minority" and the "Minority Space" stand properly defined as have been the rights and benefits delineated that will accrue to the KPs once declared 'Minority'. As such there is hardly anything left for one to make an addition. Nevertheless, having put in some labor in the campaign of seeking minority status for Kashmiri Hindus -as envisaged by law (courtesy Prof G K Muju led Kashmir Minority Conference), I may add something supplemental to the point canvassed in the AD.

Projection is well made. Will it generate a commensurate response from the quarters concerned is a question hard to answer? Experience tells us that whenever a right that should come naturally to the KPs, as a consequence of law, there is a remarkable congruity across the political spectrum that is in view in J&K – NC, BJP, PDP included – to stall its flow and deny the accrual.

The AD has made mention of Feb. 2014 report prepared by 31MPs (belonging to different parties) where after the MHA held that the KP migrants, being Hindus, can't be granted the Minority status. In December 2017, the BJP/PDP coalition Government, in J&K, told Supreme Court that implementation of National Commission for Minorities Act 1992 (Act) is not binding on it and "it is sole prerogative of the State Legislature to take decision on this aspect that State government will consider and examine the need and feasibility of setting up of State Minority Commission at the relevant point of time as and when need arises based upon the critical study of the social and educational backwardness of the minorities spread across various regions of Jammu and Kashmir." Media reports mentioned that this was conveyed in an affidavit submitted in reply to the petition, filed for seeking directions to the state government to institute Minority Commission and а explain under which law minority benefits were granted to some sections of the State's population when Act was not applicable to J&K.

Matter is pending consideration before the Apex Court. We are still in wait for its order. Nevertheless, after going through the contents of the government's plea (as reported in the media) couple of disturbing thoughts crossed one's mind that made him apprehensive of the State's intentions. Situation on this front is no different even today.

When asked to explain under which law it was granting benefits, reserved for the minorities, to a section of population in the State – which numerically constitutes a majority here, the government, then, took a stand that the section stood notified as a 'minority' by the Central Government under provisions of the Act and benefits flow to them under welfare schemes of Union Ministry of Minority Affairs. Applicability of these schemes, according to the State government, was not related to the applicability of the Act. It was said then that some of the benefits accruing to the minority (majority in J & K) flow from Prime Minister's 12 Point Program for the welfare of minorities "in spite of the fact that the Act is not applicable to the State of J&K."

State government said that it was the Central Government which notifies 'minority' under the Act: and argued further that Central Minority welfare schemes, which benefit local majority community, flow independent of the Act. Could it be so? In this regard, situation for the KPs, today, is far worse than it was in 2017. Because the NCM Act 1992 now stands extended to the UT. At the cost of repetition, it may be stated here that in 2014 the MHA referred to the provisions of the Act when it described Migrant KPs as Hindus to reject their claim to be called a "minority." Mark the irony! The argument which UPA government raised in Feb 2014 to deny KPS a minority status is now, thanks to the extension of the Act, available to the BJP lead Central government to treat them similarly.

Government made a case for not granting minority benefits to the 'real minorities' in J & K as there was no law to support the scheme, and the Act wasn't applicable here. But relied on the Act to bestow benefits to the majority 'under the garb of a 'minority' definition. It was government's stand that it granted benefits to the 'majority community' in the State because the Act has notified it as a 'minority'.

This is a curious case of law making virtual a real and turning a real into the virtual

Government should know that 'Minorities' are nowhere defined in the Constitution. It is only under Section 2 of the Act that Central government is empowered to notify the "national minorities" for the purpose of the Act. If our government then did not believe in the Act – as admittedly it was not applicable here – how come it had no compunction to derive benefits out of it for a section of community as a minority which in numerical terms constitutes a 'majority' in J & K. No one can be permitted to approbate and reprobate at the same time.

Minorities in J &K have been making a demand for the grant of statutorily assured benefits available to the minorities elsewhere in the country. A day after the then State Government's stand in the Supreme Court was known, former Chairman of the National Commission for Minorities (NCM), Wajhat Habibuallh advised State government to extend jurisdiction of NCM to J & K, as he had been telling them in the past, when was the Chairman. He describes the demand of the state minorities as genuine. In 1999, the then Chairperson of the NCM, Tahir Mahmud had written to Farooq Abdullah, the then CM, inviting his attention to the miserable condition of the minorities in the State. In one communication he wrote "Our Hindu brethren are in minority in J & K State. We owe them the sacred responsibility of all that is necessary to protect their lives, properties, human rights and civil liberties." (No CH /4/ 88 NCM dtd. 21-01-1999). It evoked no response. It hardly matters now as, J & K Reorganization Act 2019 has made NCM Act applicable to the UT. The logical effect of such an extension is that what the majority community in J & K used to get by contrived definition of the 'Minority' will now receive as a matter of right, to the detriment of the

"real minorities" in J & K.

In TMA Pai Foundation case (2002) 8 SCC, 481 Supreme Court held that since India has been reorganized on the linguistic bases, therefore, for determining minority the unit has to be the State and not whole of India. Both religious and linguistic minorities are to be considered State wise. In Bal Patil's case, (AIR 2005 SC 3172) the Apex Court has made job of the State government easy by defining Minority thus; "minority as understood from the Constitutional scheme signifies an identifiable group of people or community who were seen deserving protection from likely deprivation of their religious, cultural and educational rights by other communities, who happen to be in majority and are likely to gain power in a democratic form of government based on election." It is for the State government to act in this direction. The UT being presently ruled by the Centre, the MHA has a job cut out to move in the direction.

It may be profitable here to say that in 2017 we witnessed a strange spectacle of two alliance partners, sworn to the Agenda of Alliance, speaking in different voices. The then Deputy CM, a BJP nominee, feigned ignorance about the affidavit. The prevarication of 2017 on the issue is more profoundly visible today when it comes to help the KP's cause – be it the grant of Minority status or Statutory protection of their Temples and Shrines in the Valley.

The BJP/ PDP government when in office said that it will constitute a Minority Commission "as and when need arises." As if time had not come! Tahir Mahmud had enough data before him, in 1999, when he noticed miserable condition of the minorities in J&K and invited then CM's attention to it. Nothing moved then. On the available indications nothing is likely to move even now. There is a need of a community push to the issue flagged prominently in AIKS's AD. This is the time when movers and shakers of the community have to act in unison, at least for the issue at hand. Let imagination rather than selfprojection have the way.

Now that NCM Act has been extended to J&K and that we have a "Double Engine" government in place, it is time for the GOI to walk that talk and redeem its pledge and grant KPs what is due to them, in terms of the relevant law. Or, should we wait for the Supreme Court to goad the Central government to show a 'real' concern for the 'real minorities' of the State. P S: GOI has recently nominated to the NCM, a person from Kashmir who belongs to the majority community living there.

# JKVM-GKPD CONCLAVE Revenge of the Lamb

hether the recently held two-day community conclave held in the national capital of Delhi will reinvigorate our struggle remains to be seen, but there were many stories and side stories and take-aways from the exercise. One which I am tempted to write about is that our **little lambs are ready for the revenge**. Our young ones are no longer getting carried away by false narratives, a la – 'if you were not born then your ancestors did it' famous line of wolf and the lamb story. Even in The Kashmir Files too, the lamb, err the main protagonist too is shown caught in the web of institutionalized false narratives perpetuated by a Left Liberal

eco system in the country, where victims are projected as perpetrators and murderers as dreaded as Yaseen Malik as Gandhi preaching non-violence. Our young ones fanned across institutions in the country responsible for creating future leaders in multiplicity of disciplines, were fed on this diet of 'Kashmir being the story of uneven distribution of resources where 'your ancestors' had usurped the lions share and you deserved to be shunted out'.

As things started unfolding, we soon realized that Kashmir uprising was not an impromptu phenomenon, as some Pak apologists would have us believe as a fallout





of 1987 rigged elections. That may only have hastened its happening, but it had been in the making for a very long time. Its journey from drawing board stage to actual on roads has had many architects, engineers and political dramatis personae involved with its edifice. Also how to create a narrative post its happening in the power corridors and public at large in India and around the world through lobby groups and media houses had already been charted out and put in place.

However, in keeping with all aspects of the warfare strategy that surprise is an essential element of armoury, we were taken unawares, and India caught napping. So before we could fathom what had happened we crash landed on various destinations and refugee camps in Jammu and Delhi; and before we could even realize what had hit us, the lobby groups were already at work in



institutions including Press Club of India and JNU, reeling out the sob stories of 'usurper' (lands, jobs, resources) v/s the 'poor and deprived'.

So, our saga - death, deceit and displacement had no takers, and with apathetic Government and insensitive and unresponsive media, our stories of personal tragedies got lost amid the din of fake narratives crisscrossing the labyrinths of power and influence. We had definitely lost the game at the narrative building, realizing sooner than later that we had to rely on our own cerebral strength. And with Pen as weapon, knowledge as power and never-say-die as spirit, it literally has been no less a feat than that of Greek God Phoenix's rising from ash, intertwined by grit and resilience, individual trials and collective triumphs. And by turning adversity into an opportunity and our young generation trotting





across the continents and globe and carting many a success stories in the corporate world, today we have turned tables on our detractors and those who had written us off.

But we know our victory is not complete till we have reclaimed our land. It may not happen in our lives, so the gen next has to be readied for the final assault and concluding push. So far we had lurking doubts whether the agony and saga of great betrayal, deceit and loss of roots had effectively percolated down to our generation next and whether the pain has entered the race memory. But it was heartwarming to see very young boys and girls playing as volunteers at the conclave, sort of interning (by their own admission) to be ready for induction into the final and decisive battle (of attrition and wits). However, it was, two young kids—Vitasta Koul and Vassu Raina—barely in their teens, who captured





the minds (and hearts too) of the audiences with their respective perspective of the whole saga and how to see themselves fit into the narrative and carry the struggle forward.

Hearing them was a real treat to senses. One thing noteworthy in both the accounts was their connect with their grandparents and faith and trust they have in them. For Vitasta Koul, sensitive as girls are, she often heard her father speak of his youth been lost in pursuit of livelihood, rebuilding life brick by brick in alien land and environment, and as avid cricketer not chasing his cherished dream of playing Ranji for the state and landing a job he so abhorred. She said she often heard her father and grandfather's vearning for the home that she can identify with their pain. She spoke with so much passion and a sense of carrying forward the flame of struggle which evoked thunderous applause from the much appreciative audiences. For Vassu Raina, he was on a different trajectory and never figured or registered when his parents spoke about 'home' and things about the 'great escape' till The Kashmir Files happened. He said he decided to watch the movie independently, and what he saw did not move him at once, but when the incidents were corroborated verbatim by his grandmother whom he calls 'Toshi' (who had



not seen the movie by then), he was hit hard by the reality of the situation. So, for Vassu, TKF has been the moment of reckoning and he is avowed soldier of the struggle.

nternational mother tongue day was celebrated by Centre for Kashmiri language literature and culture of All India Kashmiri Samaj on 4th march,2023 at the Kashyap Rishi Bhawan, Noida. Sunita Raina Pandit and a book on Munshi Prem Chand in Kashmiri by AN Prashant.

Dr. Bhat said that the center has also awarded several eminent Kashmiri personalities till date whose contributions have been monumental. He said that naming the award in the name of Prof. Omkar Koul a world famous linguist will further raise the stature of the award. This year's award was presented to Sh. Omkar Nath Shabnam an eminent Poet for his contribution to Kashmiri literature.

On this occasion an audio course in Kashmri conceived, written and developed by Dr. Roop Krishen Bhat was also formally launched on YouTube. # The exiled and persecuted are displaced at home and away from home

Kashmiri Hindus are in the 34th year of exile covering almost two generations, and a new generation has emerged after the first generation persecuted Hindus or to put it plainly children of the first generation refugees who had to flee Kashmir. That apart, one thing that goes undiscussed is that many exiled/ refugee communities in the world shrank in numbers in the distant past. Kashmiri Hindus too might have shrunk more in percentage compared to Kashmir Muslims due to constraints of living in camps first and now due to uncertainties coupled with materialistic, false notions of small happy families being imposed on such ethnicities globally off late. Communities like the Kashmiri Hindus are the latest civilizational victims facing this ethnic cleansing and decline. 34 years may not be close to 50 years, but is very close to 40 years and the memories may fade soon.



#### Political Incompetence Just to keep the Issue Boiling

As I write this I remember how last Sunday Rahul Gandhi unfurled the Tricolour in Lal Chowk Srinagar. Faroog Abdullah of NC and Mehbooba Mufti of PDP both had joined his "Bharat Jodo Yatra" just a few days before this. The next day again, Omar Abdullah and Mehbooba Mufti of PDP joined the Bharat Jodo Yatra. But they skipped his unfurling the Tricolour in Lal Chowk, Srinagar. No doubt they escaped being questioned on their regular vociferous insistence for years that unfurling the Tricolour is "provocative" (and invitation for violence).

So, PDP/NC don't do things that others do and themselves hesitate to do what others do on this matter. The crackdown on terrorists for the Jammu attacks a fortnight before was quoted by Dr Farooq Abdullah as revenge politics that will instigate violence. News channels blared Farooq's warning for a few

Kashmiri Hindus from their ancestral land year after year. The house arrest of NC, PDP top leaders during abrogation of Article 370 in 2019 is forgotten even by them yet, in the Parliament, only Congress and Vaicko of MDMK raised this matter. The house arrest itself looked consensual as, neither did PDP. NC leaders complain nor start agitations of being kept in "house arrest". Complaining against the house arrest seems to be an insignificant issue rather than nurturing the uncertainties and passively supporting separatism. From "don't unfurl the Tricolour in Lal Chowk", to "talk to Pakistan" to, now going completely silent. This is clear political incompetence that is getting exposed. After giving statements and suggestions just to keep the issue boiling, now keeping silent, except during terrorist attacks or even counter terror actions.

for decades, but now with the frequency of such contradictions and platforms available for people to question politicians have increased many fold. Recently Dr Farooq Abdullah walking away from the interview of Navika Kumar on being questioned about the 1990 exodus during his tenure is yet another thing, irrespective of the manner in which Navika Kumar questioned him.

Coming back, Kashmiris of all hues have been aware for decades that the whole pretence of disagreeing with whoever is in power in the Central Government is getting more predictable and certain. Now neither the Central Government nor the people living in Kashmir care much for this. As for the Kashmiri Hindus, who are unable to return, they are the worst sufferers because all these postures are doing their best to distance the

more determined. Politicians in are often seen to be changing their stance. In Kashmir it turns out to be more astonishing as

well as acceptable, and looks like even separatists are regularly being sent signals of approval for separatism. Frequent political U turns would have discredited some politicians so much that decisions taken from the Central Government seem to be going down well in Kashmir. It might be absurd for me to make this statement considering that Kashmir is considered to be too volatile to make such observations, but, this is an assumption that can be made now. Those who don't seem to have any suggestions, solutions or determination keep repeating statements like "Talk to Pakistan " and keep blaming the Central government after every terrorist attack or the killing of civilians in Kashmir (which included migrant Kashmir Hindus even after 32 years of exile). What I notice is that irrespective of the hype and opposition to

every move taken by political adversaries, the whole thing fizzles out after another statement they give to the news media. But in this fast moving social media age intelligence, foolishness or pretence is no more hidden; be it by politicians, bureaucrats or ordinary people themselves.

## Hindi Movie "The Kashmir Files" and another Routine Opposition

At the national level if you look at the criticism for the Hindi movie "The Kashmir Files" it largely came from politicians who happened to be in the opposite camps and this included a statement from Shiv Sena the former ally of the BJP in Maharashtra. Shiv Sena was the only party far away from Kashmir to genuinely address the issue of Kashmiri Hindus but here too we saw the minor glitches in the form of namesake opposition resulting from compulsion of opposition politics. So, the frequent political U turns have discredited politicians in front of their own voter base at least on matters of national importance and they now silently approve what the ruling political parties do, as these matters of consensus are deliberately horrifying) seem to be the last flickers. History, events and the march of human civilization/ progress itself owes many of its landmarks to unexpected incidents wherein human beings and ideologies merely happen to be in favourable positions just for a very short period, even if the impact is for centuries.

Great landmark, watershed moments in the histories of civilizations sometimes owe it to unseen factors. We have seen such examples in Europe in ancient as well as medieval times that changed society drastically for the better. Be it the rise of nations in Europe or the rise of Jews to prominence in that landscape. Here we are talking of a nation and territory that is very much within our own control.

#### Now too it is the right time to undo the exodus

In 1990, we saw it happening in front of our eyes when those in power avoided accountability over Kashmir, primarily due to personal political troubles. being opposed by opposition parties. The reason as to why I delved so much into this point, is to present these examples here.

Just like the present government at the center marched past after abrogation of article 370 in August 2019, those who opposed it are also not raising the issue of abrogation any more, except when there are terrorist attacks and that argument is also now getting feeble, irrespective of the fact that it clearly looks like deliberate detraction and blame game and non-constructive criticism. I once even heard someone in a discussion saying that the targeted killings in Kashmir (even if over the centuries. 34 years is not a small number but is enough, not just for Kashmiri Hindus but for our Indic civilization in particular. The time has come to ignore anyone and everything that routinely crops in front of us in the form of meaningless statements from people who enjoy their few hours of fame, but have no power, determination and even justification. The time has come to reverse the exodus ignoring the detractors and exodus deniers. They don't need to know everything. They don't need to be even heard, they have nothing to say either.

# NHRC Takes Serious Note of Failure In Granting Justice to Martyrs' Kin

JAMMU, Oct 30: The National Human Rights Commission (NHRC) while taking serious exception to the failure on the part of J&K Government in granting justice to family of martyr Sarwanand Koul Premi and his son Virender Koul who were gunned down by militants in May 1990 in Anantnag district of South Kashmir has issued fresh directives to the UT Government through its Chief Secretary to submit the comprehensive Action Taken Report (ATR) to the Commission regarding the case within a period of three weeks.

The NHRC issued the fresh directives to

the J&K Government after the case came up for hearing before it on October 26. Premi, a well-known educationist, writer, poet and a social activist was kidnapped along with his son from village Soaf Shali in Anantnag district in May 1990 as he had raised his voice against militancy and separatists accusing them of ruining the centuries old composite culture of Kashmir where Hindus and Muslims lived in complete harmony. The bodies of both father and son duo were thrown in Anantnag town bearing marks of torture.

Since then, the family of Premi was

running from pillar to post for justice demanding action against the militants responsible for the heinous crime and those who looted their property and torched their house etc.

The NHRC, in a fresh notice to J&K Government, through its Chief Secretary, has directed him that a comprehensive Action Taken Report (ATR) be submitted by it within a period of eight weeks. The Commission also took serious exception that the Deputy Commissioner, Anantnag has failed to implement the directives of erstwhile State Human Rights Commission (SHRC) of J&K to ensure the safe custody of the left over property of the complainant and also to recover the encroachment as the Deputy Commissioner is bound to ensure the safe possession and custody of the migrant property which the officer has failed to do, it observed.

Taking a serious note, the NHRC has directed the J&K Government that the additional/complete report as directed by the Commission in the matter be sent latest by 31/12/2022, for further consideration of the Commission.

The Commission while reprimanding the UT Government observed that the directives have not been translated into action so far due to discriminatory approach that amounts to denial and deprivation of the legitimate right of family of the complainant. The complainant, Rajinder Premi, son of the martyr has prayed for early implementation of the SHRC judgment dated 12.2.2012 in letter and spirit, translating into action of the decisions of a high level meetings held on 19.12.2012, 22.1.2014, 14.1.2017, 12.10.2017 and 4.10.2018, immediate issuance of record notes/minutes of the meeting held on 14.1.2017 and 12.10.2017, early orders of construction of a community/cultural center at the native place of martyr in Soaf Shali, Anantnag and commemoration for literary and cultural work of the martyr by the Culture Department, J&K Art, Culture and Languages.

The Commission expressed its displeasure the way the UT Government was responding in the instant case for the reason that the State Government has failed to produce it on record its willingness to implement the decision of the DB of J&K SHRC dated 22.2.2012 unmindful of the fact that the matter is pending since 2012 and almost nine years have lapsed. The Commission also observed that the decision of the DB has not been challenged so far by the J&K Government and thus has attained finality by now.

The Commission also issued directives to the Chief Secretary, UT of J&K to submit the final /supplementary report on steps taken in furtherance of implementation of DB decision dated 22.2.2012 within four weeks."

The Commission further observed that in the instant case, instead of complying its directions qua implementation, in toto, the recommendations of the erstwhile SHRC made in favour of the family of the complainant, the State is raising issues concerning authority/ powers / functioning of the Commission and that too not in good spirit. The Commission deprecated the conduct of the UT authorities in the instant case. It is not the case that the State Government is not inclined to implement the recommendation of the DB of erstwhile SHRC but the issue is that how long the State would take to implement the same as Justice delayed is justice denied.

The Commission further observes that vide this report, a request has also been made by the State to defer the matter till the pendency /outcome of the writ petition filed by the UT of Jammu and Kashmir before High Court of J&K at Srinagar.

The Commission has considered the request and is of view that it has already been made clear in earlier proceedings that the High Court of J&K has not stayed the proceedings of this Commission which makes it abundantly clear that with regard to the implementation of the erstwhile J&K SHRC recommendation, there is no legal impediment.

The Commission while passing strictures against the UT Government observed several directions have been given by the NHRC

earlier to give effect to the recommendation of erstwhile J&K SHRC dated 22.2.2012. At the cost of repetition, the Commission will appreciate if the J&K Administration realizes the pain and agony and the prolonged misery of the complainant who has not only been ousted from the home State but also suffered huge personal loss resulting him to run from pillar to post to get justice. The family had been subjected to forced ousting resulting thereby a huge harassment both from society point of view, besides personal loss. So, it is expected that the J&K administration must sanction a reasonable amount which could be sufficient to compensate their personal, physical and other losses and such compensation should be awarded in a time bound manner without any delay.

The Commission is of the opinion that to uphold the laws of protection of human rights which include the dignity, equality, life and liberty, resulting thereby it becomes an imperative on the part of the J&K Administration to uphold the Division Bench recommendation of the erstwhile J&K SHRC dated 22.2.2012 in letter and spirit without any further delay and in any case not later than six weeks from the date of the order.

The Commission further directed the J&K Police Department to issue a complete revised and rectified FIR, giving the full factual details of trespassers, looting, kidnapping etc., as despite the direction of the erstwhile J&K SHRC to handover the case to some other police officer not below the rank of

Dy SP, nothing has happened. Therefore, it is incumbent upon the J&K Administration to initiate special investigation team to look afresh into the heinous crimes to bring the culprits to book for speedy justice to the victim.

The Commission observed that erstwhile J&K SHRC has also asked Dy Commissioner, Anantnag to ensure compensation regarding destruction of pucca tin surfaced cow shed but nothing has happened so far. J&K Administration is expected to expedite the process.

It further observed that erstwhile J&K SHRC had directed Deputy Commissioner to ascertain the factual position regarding torching of the residential houses by the miscreants but nothing was done so far. If the houses were occupied, the actual owners of the houses are entitled to have the rent which should be calculated and paid to the victim family. The State Commission had also directed the Deputy Commissioner, Anantnag to ask Tehsildar to contact the complainant so that he could pay for the transportation of the household belongings of the deceased family, which were to be transported to Jammu for handing them over to its owner. The household goods were kept under supervision of Mam Bhat. The Commission has failed to understand that why nothing has been done so far. The Commission issued directives that the same be done within six weeks from the date of the order.

The hapless community of the displaced Kashmiri people has been living in exile/adapted places for the last 32 years with little hope of any support or succour from the powers that be. India is predominantly a caste-driven society where the Brahmin/Pandit is such an entity that does not deserve good-will or sympathy! Secondly, the timid Hindu is afraid of speaking out in favour of the homeless Kashmiri. Thirdly, the politician gives importance to the numerically strong communities! After another twenty odd years the fourth generation may know very little or nothing about their ancestral home!

Sometimes I go back to my childhood memories and realise in hindsight that we were a foolishly trusting people. The signals of genocide had been sent very early in 1930, 1947, 1986 but we shut our eyes and ears and put our heads in sand instead of facing the truth. After 1947, we forgot to learn Sanskrit. Little did we realise that there would be negligible number of seats for the minority youths in Medicine and Engineering. But most of us opted for biology and mathematics. As a result we could not claim our rich ancestral heritage. A community is known by her contribution to knowledge. We knew nothing about it! What our minds were trained in was to dislike everything that constitutes our heritage. One's 'tilak' mark was ridiculed, so was 'yagyopavit'. Yet we trusted!

Our greed had reached new heights! Some families merged 'yagyopavit' ceremony of their son with his marriage ceremony so that the would-be bride's family would arrange a 'GOLDEN YAGYOPAVIT' for the would-be son-in-law! Such sad and shameful act on the part of some persons brought disgrace to the entire community. At the end of the day, we found ourselves under the hot sun with no home, no name and no press coverage!

Do we need to reclaim our heritage now? I believe that Sanskrit learning is of vital importance for our youths to speak to the world about the creative quality of our ancestors. 'Katha Saritsagar' guided the world in creating short-stories. Abhinavagupt created ample space for the devotee as well as the literary critic. We need to learn more about literary critics, grammarians, scientists, women warriors, rulers, history, economics, sociology, warfare etc. from Sanskrit literature that has been written with great difficulty for over a millennium, until the king Budshah replaced Sanskrit with Persian.

I urge the youths to work hard, read and understand intensely, put in extra energy to learn Sanskrit language so that one is able to understand the original Sanskrit texts in future. Literature opens one's mind to societal requirements and limitations.



Fakhruddin Ali Ahmad, Syed Nurul Hassan were some of the other luminaries who ensured that Indian History, already distorted by the Europeans, was given a communal twist by the leftist agenda driven 'historians' of Delhi. Akbar became Akbar the Great (his acts of Jazia imposition were diluted), History of Delhi Sultanates became the History of Medieval India at the cost of the Cholas and the Vijayanagar Empire; the Ahom Kings who defeated Mogul army 17 times were not even a part of the footnotes. However, as the light of education and independent thinking started percolating, people started resenting this marginalization of the Hindu community and twisted Indian history. Facts started emerging as people started challenging the JNU driven historical interpretations. Late Mr BB Lal and Mr KK Muhammed, the famous Archaeologists produced irrefutable evidence of a Temple structure existing under the disputed structure at Ayodhya. History needs acceptance, not living in denial.

As per various Hindu organizations and historians, there are records of over 40,000 Temples of Hindu/ Buddhist/ Jain faith that were looted, damaged, desecrated or destroyed by the armies of Religion of Peace! From Mohammad bin Qasim's conquest of Sind (708-11) to Tipu Sultan (1751-99) in deep South, most Muslim invaders and rulers made it a practice to demolish places of worship of non-Muslims as a State policy. I have seen the ruins of Martand in Kashmir the handiwork of a rabidly bigoted despot, Sultan Sikandar Shahmiri (1389-1413), known as Sikandar Butshikan (breaker of idols), who singlehandedly destroyed hundreds of Hindu and Buddhist Temples in Kashmir, forcing Hindus of Kashmir to either

convert to Islam or get killed. Across India, we see signs of such destruction. Once, at the Ajanta caves, an American tourist told me," You guys need to be thankful that these caves got hidden for some centuries. Otherwise, who knows what havoc Aurangzeb would have wrecked on these caves!

Francois Gautier in his book 'Rewriting Indian History' (1996) wrote, "The massacres perpetuated by Muslims in India are unparalleled in history, bigger than the Holocaust of the Jews by the Nazis or the massacre of the Armenians by the Turks; more extensive even than the slaughter of the South American native populations by the invading Spanish and Portuguese." Who in India can forget the torture suffered by Guru Arjan Dev Ji at the hands of Mogul King Jahangir (1606 CE) for his failure to convert to Islam? And the martyrdom of Guru Teg Bahadur Ji at the hands of the cruel and fanatic Aurangzeb on November 24, 1675 CE - for his refusal to convert to Islam. The entire life of Guru Gobind Singh Ji (1666-1708 CE) was spent in fighting Islamic bigotry; he sacrificed his 4 sons in the process but did not vield to Aurangzeb. This is what our Muslims intellectuals need to acknowledge, not deny!

Persian chronicle **"Baharistan-i-Shahi"** tells us that a cruel Mongol Chieftain Zulqadar Khan or Zulchu, reduced Srinagar to mere 11 households through wanton killings, loot and plunder. We have a saying in KP Community," Kashiri Gaya 11 gare,", referring to the time when just 11 households were left of a prosperous and peaceful community.

Incidentally, such acts of vandalism, in the name of Islam, have not been witnessed in India alone – wherever the flaming Sword of Islam went, it brought about death and destruction. Arab invasion of Europe (711 CE) led not only to conquest of large tracts of land but also to wholesale conversion of Churches to Mosques. **Hagia Sophia**, the Christian Cathedral built in 537 CE at Constantinople (now Istanbul) was converted into a Mosque in 1453. It was declared a **National Museum** by the revolutionary and reformist statesman **Mustafa Kemal Atatürk** in 1935 as a symbol of 'secular' Turkey. The decision was reversed in July 2020 and the Museum again got converted to a Mosque, in step with the Islamist policy of current regime. Likewise, destruction of Zoroastrian Temples of Fire in Iran started with the Muslim conquest of Persia (633–654 AD). Interesting to note that the High Priest of Jihadi Islam, Mohammad Iqbal has praised these acts of vandalism in his iconic poem 'Shikwa' and I quote:

Thay Hameen Aik Teray Ma'ar K Aaraoon Mein, Khushkiyoon Mein Kabhi Lartay, Kabhi Daryaaon Mein Dee Azanein Kabhi Europe K Kaleesaoon Mein Kabhi Afreeqa K Taptay Hoay Sehraon Mein Shaan Aankhon Mein Na Jajti Thi Jahandaaron Ki Kalima Parhtay Thay Hum Chaaon Mein Talwaaron Ki Qaum Apni Jo zaro Maal Jahan Per Marti, But-Farooshi Ke Iwaz But-Shikni Kiyoon Karti! (Reference is to Mehmood of Ghazni who was requested by locals and Pandits not to desecrate Somnath Temple and take gold instead but he preferred to be an idol-breaker)!

Tu He Keh Day K Ukhara Dar Khyber Kiss Nai Shehr E Qaiser Ka Jo Tha Is Ko Kiya Sir Kiss Nai? Toray Makhlooq Khudaoon K Paiker Kiss Nai? Kaat Ker Rakh Diyeah Kuffar K Lashkar Kiss Nai? Kiss Nai Thanda Kia Aatish Kada E Iran Ko?

#### Loosely translated:

We alone were the marshals of Thy troops! We were fighting on land as well as on the seas (for you); We offered Namaz in the Cathedrals of Europe and in the scorching African deserts. We never cared for the grandeur of monarchs but recited 'Kalmah' in the shade of swords. If we (Muslims) had been greedy of worldly wealth, we would have become idol sellers, not idol breakers! Tell us (O Allah), who uprooted the gates of Khaibar (mountain pass that led to undivided India from Afghanistan)? Who conquered the city of Qaisar (Caeser)? Who destroyed the images/ idols of false gods? Who slaughtered the armies of Kafirs (infidels)? Who extinguished the Fire Temples of Iran?

While the poem is in an expression of grievances (against Allah), it is a telling comment on the mindset and thought process of Islam and Jihad. It justifies destruction of the 6<sup>th</sup> century statutes of Buddha in Bamiyan, Afghanistan by Taliban (2001). Or what happened in Anantnag (Kashmir) in 1986 and the Ethnic cleansing of Kafir Hindus in Kashmir Valley in 1990. It has happened in Spain, Cyprus, Turkey, Egypt, Afghanistan, South-East Asia – wherever Islam rode in. It is happening in Kenya, Nigeria, France, Belgium, the UK, Horn of Africa, Somalia etc. even today!

Add to this the sense of hurt amongst Hindus & Sikhs due to partition of the country on religious lines. Muslim League led by Aga Khan, Iqbal and later Jinnah first demanded a separate electorate for Muslims and later,

creation of a separate country for Muslims, Partition resulted in massive transfer of populations (16 million?) and large-scale communal killings (two million?) mostly in Punjab and Bengal. Hindus and Sikhs migrated from areas given to the newly formed Pakistan while a segment of Muslims left India for the new country. Hindus and Sikhs of Punjab and Bengal were bitter at the loss of their homes and hearths, for no fault of theirs. Violent nature of the partition created an atmosphere of

hostility and suspicion between the communities involved as well as between India and Pakistan that affects their relationship to this day. But the worst part is that not all Muslims from India moved to the 'new' Land of Islam for the Pure! The portion that did not move to Pakistan in 1947 has grown to almost 18% of population today and, is now demanding special privileges and exclusive laws (a repeat of pre-partition era?). They are asking for exemptions and immunity from civil norms (wearing Hijab in schools,

education in Madrasas etc), not adhering to laws passed by the Indian Parliament (CAA, Triple Talaq etc) and even not accepting decisions of various courts (Ram Janmabhoomi, Kashi Vishwanath etc). Needless to say, such obduracy not only hurts the State but creates ill-will amongst different sections of society.

#### Way Forward:

The only way forward, the way to reconciliation between two communities that have, for over last ten centuries been living as neighbours, would demand maturity from both sides of the communal divide. To my mind, the following steps can help:

#### **Truth and Reconciliation Commission:**

We have the classical example of Truth and Reconciliation Commission of South Africa, set up in 1995 to help heal the country and

> bring about a reconciliation of its people by uncovering the truth about human rights violations that had occurred during the period of apartheid. Its emphasis was on gathering evidence and uncovering information-from both victims and perpetrators-and not on prosecuting individuals for past crimes, which is how the commission mainly differed from the Nürnberg trials that prosecuted Nazis after World War II. In the words of Archbishop Desmond Tutu," The South African TRC

represented a major departure from the approach taken at the Nürnberg trials. It was hailed as an innovative model for building peace and justice and for holding accountable those guilty of human rights violations. At the same time, it laid the foundation for building reconciliation among all South Africans. Many other countries dealing with post conflict issues have instituted similar methodologies for such commissions, although not always with the same mandate. The South African TRC has provided the world with another tool in the struggle against impunity and the search for justice and peace."

While past can't be undone, acceptance of past mistakes is often the first step towards a solution. Today's Muslims can't be directly held responsible for sins of Aurangzeb or Mehmood of Gazhni or other tyrants - but simultaneously, these characters need not be eulogized as heroes by certain sections of Muslims. What can serve as salve for Hindus is acceptance by Muslims that invaders and bigots, who ruled India in the name of Islam they committed innumerable sins of torture, of destruction in India and, specifically, on Hindus and Sikhs. There is no reason to glorify Aurangzeb, the destroyer of many. many of Hinduism's most glorious symbols. There are serious historical proofs that indict Aurangzeb for destroying temples at Varanasi and Mathura. Why defend those acts? Why live in denial?

Other measures that can be discussed for long term social peace are: Privacy Notice.be links are provided in every email.

1. Allow reconstruction of two remaining (main) temples at Varanasi and Mathura. There is to be no unnecessary and contentious litigation on these two sites from Muslim side.

2. In turn, Hindus shall assure Muslims that no more cases of destruction of Temples/ Gurudwaras shall be raked up. A legal frame work shall need to be built in, making the terms binding for all communities. Hindu Sant Samaj and the RSS have been saying that since 1964.

3. The new law or agreement shall not apply to acts of wanton destruction of Hindu Temples and other properties in Kashmir.

4. An agreement that Muslims shall agree to being treated at par with any other citizen of India, without any separate or exclusive laws. This means that the Article 44 of the Constitution, enshrining the Spirit of the Constitution shall prevail over personal laws of different communities. 5. Any religious community that constitutes up to 5% of India's total population shall qualify as a Minority under the constitution. This definition alone can get justice for the genuine minorities like the Parsis (0.006%), Jains (0.4%), Buddhists (0.7%), Sikhs (1.7%) and Christians (2.3%).

It is very important for academics and opinion leaders to accept that most of the Muslim population in Indian subcontinent has Hindu roots; invaders did not bring their women along - they married local women after converting them since they were the victors. Muslims shall have to accept that they are Indians first and foremost; that religion is personal and the romantic notion of Iqbal's Muslim Umma stands rejected by the 57 members of Organization of Islamic Countries (OIC). Today's realpolitik and diplomacy work on the concept of Nation-states; commonality of religion, political philosophy or language may not always work. Disintegration of Pakistan (1971) and USSR (1991) are classical examples. Today, Bangladesh, a predominantly Muslim country, does not want to accept Rohingya refugees, even though they are Muslim!

#### In 1910, Iqbal very romantically wrote:

Chīn o-ʿArab hamārā, Hindūstān hamārā, Muslim hain ham, watan hai, sārā jahān hamārā

China and Arabia are ours; Hindustan is ours; we are Muslims; the whole world is ours

The sooner this romantic notion is given a burial by Muslims in India, that much quickly doors of their acceptance by other communities shall open. Once they accept their identity as Indians and not the Pan-Islamic victors' who ruled India for 1000 years, their socioeconomic emancipation shall start, as part of mainstream India. That the concept of 1910 poem runs in face of Iqbal's own poem of 1904 'Saare Jahan se achha' only reflects the fickleness of a poet. Muslims of India need to realize that their fates are linked to the fate of 130 Crore India

# **Infinite Nature of God**

hri Paramhansa Yogananda has said, "We have descended from the infinite into finite. Yoga is withdrawal of the attention from externals in order to focus it on the inner source of truth. Only in this way, we can discover how God has condensed His consciousness into the multitudinous finite

consciousness present in the body is beyond human consumption. Though externally we are made of flesh, behind its gross cells are electrical currents, known as life currents, and behind these subtle energies, are the thoughts and perceptions.

We have experienced that the searching



forms of his creatures and the Universes, they inhabit. The human body is the most intricate of all Gods' creations. A single original cell by multiplication of the process builds up trillions of cells around itself to create the body temple that houses our divine and soul consciousness". Thus the reverend Swamiji revealed that the power and extent of the mind is infinite but at the same time, there is a point beyond which ideas become too subtle to follow. From that point (sphere) where the mind cannot penetrate, God is pouring truth-The cosmic intelligent vibrations (God's essential light). Thus, if we use the mind properly, we can understand how God is beyond mind and intellect and that God's true nature can be felt only through intuition (That is soul power of intuition). We have to make concentrated efforts by adopting regular mode of meditation to develop the power of intuition and can find God-consciousness through the Super-conscious mind – that is the nucleus of mind and intelligence. His infinite nature is thus revealed to men through the intuitive Super-consciousness of the soul. The ecstasy felt in meditation reveals the presence of eternal joy spread over all creation. The light which is seen in meditation is the Astral light. To explain the Astral light, it is revealed in the scriptures that, "everything on the mental plane has a counterpart made of Astral light, a light that is subtler then the electromagnetic energy of the

atom". In Hindu Scriptures, it is called "Prana" (energy). Sri Paramhansa Yogananda called it "Lifetrons".

The wise know that the suffering is not the work of God and it is the fog of most intricate of all Gods' ignorance that causes delusion in a human being and thus, one stumbles through life. "Tamasic" (ignorant) action is that which is instituted through delusion, without measuring one's ability and disregarding the consequences,

the loss to oneself, health, wealth and influence and also harm to others. But when the fog of ignorance is removed by meditation, you will see the right path. To explain what meditation is in true sense, it is concentration upon God. The term is used in general sense to denote practice of any technique to divert the attention and focus it on some aspects of God. In the specific sense, the meditation refers to the end result of successful practice of such techniques direct experience of God through intuitive perceptions. It is the seven steps "Dhayana" of the eight-fold path of yoga described by Sage Patanjali. It is achieved only after one has attained that fixed concentration within, whereby, he is completely undisturbed by

sensory impressions from the outer world. In deepest meditation one experiences the 8th step of voga path – 'SAMADHI' – communication or oneness with God.

Yoga means in Sanskrit "Yuj" (union). It maybe stated here that there are various types of yoga methods: 1) Mantra yoga 2) Laya yoga 3) Karam yoga 4) Bhakti yoga 5) Jnana yoga and Hatha yoga. The sage Patanjali, the foremost exponent of yoga paths has outlived eight (8) steps by which the "Raja Yoga" attains the 'SAMADHI' or union with God. However, the most prominent step is "Pranayama"-The control of "Prana" - subtle life currents, and subsequently the other important step is "dharma" – concentration.

In conclusion, the crux is that a human being, among other material attachments, various strains and stresses of life must give first place to God in his heart by

creations.

following the rules of prayer being the simple and easiest way to love God. The first rule in prayer is to approach the God with legitimate desires and pray for their fulfilment. What is important is to be practical and earnest about prayer, and concentrate deeply, on what you are praying. As life is a continuous struggle for material

and spiritual achievements and is surrounded by enemies, diseases, poverty, suffering, bad habits and wrong desires, it is the power of mind which is the tremendous instrument of protection. Thus, it is the MIND that must be strengthened so that awareness of the God is felt. As a human being, you have the God given power (soul power) to cast away every habit and limitations and speed over consciousness throughout creation as is apparent from Swami Vivekananda's saying, "Every soul is potentially Divine". We are limited now, but by deep, daily meditation, we become able to transfer over consciousness from the finite to the infinite and we will be free. Thus by removing the fog of ignorance, we are able to learn the God's true nature only through intuition.

A fter the publication of his two books and their subsequent numerous editions, it was time for Abhilash to pursue his childhood passion for music. He fulfilled this desire by giving voice to his words and collaborated with many Kashmiri singers following which he released a number of CDs that contained his Bhakti songs. All of his devotional songs are now available online on his YouTube channel "Abhilash vann", and these songs are often aired on FM Radio

Sharda as well. The online platform has provided him with an opportunity to reach a wider Kashmiri audience across the globe.

Abhilash is mostly known for his Bhakti poetry, but very few people know that he has also penned some witty and satirical poems that focused on themes like Graham Bell's Telephone, modernization, Vaat Paerem and his recent composition on the Corona pandemic. Abhilash's poetry is mostly spiritual and metaphysical in content.




Image: B.N Abhilash's CDs of Kashmiri devotional songs.

However, some more aspects came to fore while having a conversation with him. When asked about the future of Kashmiri Bhakti poetry, especially among the new generation, he said:

"The future of Bhakti poetry will be good, as the saying goes that no seed gets permanently extinct from the face of Earth. Although, sometimes it flowers fully while other times it does not blossom much because it is the law of nature, but the seed survives in one form or the other. In present times, it is true, that there are few people who read or listen to Bhakti poetry as the new generation has hardly any interest in it."

One of the hallmarks of his devotional poetry is that it is sprinkled with rural imagery, metaphors and similes, but some listeners have been feeling a bit uneasy over the meaning of these idioms and phrases, particularly the new generation who could not follow their language. On this, he remarked:

"Since I come from a village and my upbringing has been in that same ordinary village life, it must have an effect on my poetry, although not that much because after every few kilometers the words and pronunciations change. The similes and metaphors employed in my poem find their roots in the village as they are influenced by village life such as land cultivation, trees, birds, animals, plants etc. These things I believe have less influence in the cities."

Even after having earned a good fan following, Abhilash remains a downtrodden person and respects the response from the listeners. He is grateful to the audience who either comment or criticize his poetry. In his own inimitable style, he says:

"My poems generally receive a good response. People like and appreciate them. You can confirm it from the audiences or from YouTube where I receive many good comments from many people, and it motivates me to continue my work."

There was a time when he strongly opposed the use of mobile phones by people with the view that it was a waste of money and time and it corrupted the mindset of people, especially the young generation and led them astray. But he changed his mindset after he himself began to use it. When asked why this change of attitude towards mobile now, he said:

"It is a necessity of the time; mobile phones are not a bad thing; the whole world is connected in a fist through it. Wherever something good or bad happens, you receive the news sitting at home especially since phones with cameras have been introduced people can talk face to face. There is a blackand-white (negative and positive) for everything; unfortunately, some people misuse mobile phones which should not happen. Cybercrime has also increased. I would not like to elaborate further on this."

Exodus had a terrible effect on his life. It shattered him beyond any description. From an independent businessman who had a name and fame around big swathes of his area, he overnight became a non-entity. He lost his business, land, and above all his identity. He could not recover from this severe jolt even after 32 years of exile. He curses the governments for the past and the present for the miserable plight of KPs and for his own life. This can be gauged from his viewpoint when he said:

"There has been a tremendous effect of migration on Kashmiri Pandits, and it has made sure that our identity and existence cease to exist in the coming years. The trend of intercaste marriages has also increased. It is natural for a tree to perish and die when its roots have been cut. Post exodus, every Kashmiri household has a person who is diseased, immersed in a pool of worries. Families have got scattered; parents here and children there. Old folks have their heads buried in their hands and are living a life of sorrow and shame. We do not know if someone will lend shoulders to our dead bodies. We do not know if someone will lend fire to our pyres. Children have moved from their homes in search of jobs. God is our only hope, our protector and it's our faith in Him that makes us go on living. We are burning in the embers of worries. We have come to rags from riches."

The dilemma of returning to Kashmir haunts every Kashmiri Pandit living in exile right now. There are no clear-cut answers to

this question. Many people have died in this longing. Coming generations too are not certain about their future in Kashmir as the government does not seem to have a clear-cut policy vis-a-vis KPs. Despite wishing to return, particularly those who are born in Kashmir and have grown up in that atmosphere, they are not in a position to go there right now. Going there remains wishful thinking. One does not know how much more time it will take KPs to return. The same dilemma confronts poet Abhilash which can be inferred from his statement:

"My answer to everybody who asks me if I would like to return to Kashmir after all these years is 'No'. Because the people of Kashmir have dismissed us for the past 32 years and that too on the grounds that we are Hindus. Is there any other reason for our exodus? No Kashmiri Pandit has committed crimes akin to those inflicted on him by the Kashmiri Muslim. Kashmiri Pandits have not killed any Muslims, never burnt any of their

houses, never razed any of their shrines and never acquired their lands by deceit or force. Despite being a peace-loving community, we had to endure such suffering. Everything that we had was snatched away from us in an instant. They did not leave our homes and temples. What is left there for us now? More miseries, more suffering and an uncertain future, as the saying goes: "Jahan nahi chaina wahan nahi rehna".

# **MADHAV KOUL** AN UNSUNG AND UNWEPT HERO OF 1931

henever there has been an upheaval in Kashmir, be that political, social or religious, Kashmiri Pandits have invariably been at the receiving end. It has seen an uninterrupted continuity from times immemorial. The history of Kashmir is replete with such examples as forced religious conversion of its people bears witness to its consequences. Having witnessed worst kind of mayhem and arson in 1931, Kashmiri Pandits continued to remain vulnerable to majoritarian outrage and assault. Therefore, psychological pressures about their safety and security as a community kept constantly building on them.

The post July 1931, uprising made the soil of Kashmir politically fertile for the demonisation of its minorities particularly Kashmiri Pandits. It brings to the fore the impact of communal riots that engulfed the valley on the said month of 1931.Thereafter, the deeply embedded public sentiment against the Kashmiri Pandits started surfacing gradually and found its expression in many violent incidents of targeting the members of KP community which largely remained

unnoticed. One such incident is mob lynching of Pt. Madav Koul.

#### Madhav Koul; Who?

The aftershocks of July 13 uprising remained palpable for a long time and left its unpleasant footprints on the social relations of the people. Illustrative of it is the cruel and cold blooded murder of Madhav Koul on September 24,1931 while on duty. He was a revenue officer (Nazir) at the Naib Court of Shopian and was residing with his wife as a tenant in the house of Pt. P N Punjabi. By nature, a workaholic, he would therefore invariably hang around his duties. September 24, being the day of Ant Chhodah, his pregnant wife was busy in making sweet pudis for performing Satyanarayan Puja and that kept her waiting for the husband to break her fast. Little could she have imagined that the biggest shock of her life was in store for her and that was to receive the mutilated body of her husband stacked in a big jute sack. More appalling was to give birth to a posthumous male child sometime after his death.

#### **Narration of Facts**

Pursuant to the revolt against the Dogra regime, Kashmir saw a dislike for Maharaja's rule which eventually became an organised movement against the Hindu rule. Anything connected with it came under its destructive sweep. Since there was no dearth of religious bigots who would get provoked at the drop of the hat, his murder therefore has to be seen from the context of toxic anti-Maharaja campaign gaining momentum. It resulted in inflaming the anti-Hindu passions leading to the spewing of their venom against the Hindus which ignited the communal fires and Kashmiri Pandits became victims of the mad frenzy. Its progression led to the angry crowd shouting slogans against the Maharaja and quickly moving towards the Munsif court and police station. With Madhav Koul already in possession of such an information, he apprehended trouble for the Town and KP minority in particular. Consequent to it, he swung into action and started taking some leave for the court to secure and prevent mob rioting but that was not to happen as he was trapped by the murderous mob at Kila Bagh only to get lynched and his body mutilated. Not content with that his eyes were gouged out with sharp edged knives. The immediate provocation for making a cause before killing him came from the mob who insisted on the instant release of a Pir (Moulvi) facing trail in Munsif Court for seduction charges.

The angry mob, after satiating the thirst with the blood of slain Madhav Koul, became unstoppable and went on rampaging spree. This resulted in damage to the public property including the dismantling of the top storey of the police station, burning public and Hindu minority properties and stone pelting. Seeing the worsening situation and crowd getting out of control, police resorted to fire, a first time in the history of Shopian that bullet was fired. The administration without waiting for any further damage moved swiftly and, issued an ordinance called 19 L under which Army was deployed and powers vested with Army

preventive measures. First and foremost being his advice to the Hindu shopkeepers to close the shops and return home quickly as most of them resided near the Hindu village Bhatpara. Most of the people showed reluctance to leave as their children were trapped in the school, compounding their worries. He made them to see the logic and reason behind his persuasion after assuring them about ensuring the safety of children as a priority. To live up to his promise made to the distraught parents, he quickly moved towards the middle school and shifted the children to a safer place.

Having secured the safety of the children, the next thing on his mind was to

officers and District Magistrates to search and arrest without warrant any suspicious persons. Massive combing operations were launched by the Government in the neighbouring villages and towns to nab the killers. The main accused Khalil Banday remained absconding but the other culprits Mohmmad Sultan Nengroo, Abdul Gaffar and Mohmmad Wani were apprehended. Further to their arrest, they were subjected to the interrogation in the police station and it remains unclear till date whether two of the people died in interrogation or were sentenced to death. It is a different matter that they were declared as freedom fighters later and their families received pension by the post independent Government of the State.







# **Lumbar Strain**





umbar strain is a stretch injury to the ligaments, tendons, and /or muscles of the lower back. It can be acute due to a sudden injury occurring with lifting heavy weight, sudden twisting of lower back, not using correct technique for sports etc. It can also happen gradually over time due to abuse, overuse or repetitive movements which result in overstretch or microscopic tears in these tissues and that is called chronic strain.

Lower back especially lumbar and lumbo -sacral region is subject to considerable mechanical stress and strain as it is the junction between mobile lumbar spine and fixed pelvis. It is also a fact that assumption of erect posture by humans during evolution has thrown undue strain at lower back- lumbar and lumbosacral junction. Again, this is the area where congenital (since birth) anomalies of spine usually occur, which weaken the area and make it prone to stress. Lower back also bears much of the body's weight during walking, standing, bending, sitting etc. All that makes lower back- lumbar area prone to stress and strain, and thereby back ache.

Lumbar strain is the most common cause

of low back pain in younger and middle aged people. It occurs in either sex. It is a fact that many lumbar strains occur while performing daily activities like lifting, exercising etc. It is somewhat a life style related problem. It occurs usually because of obesity, improper use of back, bad posture, improper lifting of objects, abrupt or awkward movement or repetitive movements, an overuse or an injury to back, weak abdominal and back muscles, sudden impacts, taking new sports or activity without proper workup etc.

**Risk factors :** There are several factors that can increase the risk of lumbar strain and they are:

(i) Obesity-extra weight puts additional load and stress on the ligaments, discs and the muscles of the back, thus increases the chances of lumbar strain. Obesity is often associated with protuberant abdomen that increases natural backward curve-concavity of lower back i.e. lumbar lordosis which puts extra strain on the ligaments and muscles of back. not unusual to see people especially the youngsters sitting in abnormal postures for long time while studying, using mobile phones or laptops, thus inviting trouble for their back and neck.

iv) Jobs having strenuous physical activity where people do strenuous activities repeatedly that require bending at the back are prone to lumbar strain as there is constant wear and tear of the back. Again, people involved in lifting heavy weight are at a higher risk of lumbar strain and it usually is because of improper lifting of heavy weight by bending back instead of knees wherein back muscles are being used instead of leg muscles.

v) Sports that require sudden bending and twisting of back like tennis, basketball, golf, football etc. also increases the chances of lumbar strain. Taking a new sport or an activity can put sudden unfamiliar stress on muscles, ligaments and result in strain. As such, it is not uncommon to see youngsters especially those doing it for the first time that too without any proper workup sustain acute lumbar strain

#### One thing that needs to be stressed is that prolonged bed rest and inactivity does not help, rather it is harmful. It decreases muscle strength, flexibility, bone density and disc nutrition in addition to affecting cardiovascular fitness.

ii) Sedentary life styles- when we sit for long periods of time and do no exercise, back and abdominal muscles become inactive and increasingly weak, thus the risk of lumbar strain increases. Sedentary life style also makes you gain weight, which again is not good for back and overall health of the person.

iii) Abnormal postures i.e. natural alignment of spine- neck, mid back and lower back is not maintained while sitting, standing or walking. Good posture reduces unnecessary stress and strain on muscles, ligaments and joints. On the contrary, abnormal posture increases stress and strain on muscles, ligaments and joints of the body particularly of the back. It is during or after a workup in gym.

vi) Poor physical fitness when back and abdominal muscles are weak makes a person prone to lumbar strain, not only that it also makes a person prone to other medical problems.

vii) Excessive curvature of lower back- lumbar lordosis makes one prone to lumbar strain

viii) Pregnancy increases the chances of lumbar strain as the normal lumbar curvaturelordosis increases and the centre of weight bearing is shifted forward with the result stress on the lumbar spine increases. The women who do not do exercise during pregnancy are certainly prone to get lumbar strain than the ones who do it regularly.

#### **Clinical presentation :**

Patients of lumbar strain present with low back pain which can be sudden in origin. Lumbar strain as discussed earlier is the most common cause of low back pain in youngsters and middle age people. In addition to pain, there is stiffness – spasm of muscles of back. Back pain increases with the movements of back. There is localised tenderness i.e. pain on pressure in lower back. Back pain may radiate to buttocks but does not go down the legs. Detailed history taking and a meticulous clinical examination is very important in the diagnosis and

management of lumbar strain. It helps in choosing the appropriate diagnostic test to be done for the proper work up and treatment.

**Investigations :** X-rays are done to rule out any fracture, congenital anomaly or infection etc. of spine. MRI is certainly the most appropriate investigation for spinal problems. It is a non-invasive investigation, and shows all the details of discs and neural structures like roots and spinal cord, facet joints and vertebrae. MRI is usually not needed for diagnosis of lumbar strains. It is done when we suspect something other than a simple lumbar strain. It helps to rule out the possibility of other causes of back pain.

**Treatment :** Treatment of lumbar strain depends on the age, overall health and the severity of the problem. Aim of treatment is to reduce pain and stiffness. Rest for couple of

days when pain is acute along with medication for pain and stiffness - NSAIDS help to reduce pain and stiffness. Application of bag of ice or cold pack to the affected area for the few days- first 48 hours or so, helps in reducing inflammation and pain. After a few days, hot packs do help. Once the acuteness and severity of pain is over, one must start with mild low stress exercises and it has to be within the comfort zone. Gentle exercises started and done slowly help in quick recovery from an episode from back pain. Exercises for strengthening of core muscle i.e. back and abdominal muscles along with stretching exercises are very useful. One thing that needs to be stressed is that prolonged bed rest and inactivity does not help, rather it is harmful. It decreases muscle strength, flexibility, bone density and disc nutrition in addition to affecting cardiovascular fitness. Weak muscles and stiffness of the back caused by prolonged rest increase the back stress and back pain. Good thing is that majority of patients of lumbar strain usually recover fully within two weeks or so.

#### PM Package Employees Suspend Protest for Relocation

Package employees suspend 300 days-long protests. Surrendering before the Government, the Prime Minister's package employees under the banner of All Migrant Employees (Displaced) Association Kashmir stopped their 300 days long protest, keeping in view the complex faced by the employees and their families. In a hurried press briefing, the leadership of the package employees said that they had suspended their protest for many reasons, particularly given the financial choking of the employees, which has caused tremendous distress among their families.

"For many days, the Core Committee held several meetings with the employees and their families. They learned that employees were in complete chaos and confusion as their issues multiplied daily. They were in complete distress. So the Core Committee, after discussing the pros and cons, took a unanimous decision to suspend the protest," said AMEAK (D) leader, adding that "We suspend the protest and desperately surrendered before the Government as the response of the Government towards their primary demand of relocation remained very cold in 300 days of their legitimate struggle". Pertinent to say that the police detained scores of PM package employees on 15th February 2023, including half a dozen female employees who were protesting near the Press Club, demanding the release of their last eight months' salaries and relocation to Jammu.

His colleagues said that Sharma was not reporting late to duty following an earlier spate of terror attacks on his community members."Terrorists fired upon one civilian from minority namely Sanjay Sharma S/O Kashinath Sharma R/O Achan Pulwama while on way to a local market," the Kashmir Zone police said on Twitter. Deputy inspector general (DIG), South Kashmir Range, Ravees Bhat, said it was a "planned attack". He said armed security guards had been placed on duty in the village.

#### Another Target Killing in the Valley

Terrorists on 26th February shot dead a 40year-old Kashmiri Pandit in the Pulwama district of Jammu and Kashmir while he was on his way to a local market. Sanjay Sharma, who worked as an ATM guard, was shot in the chest at point-blank range barely 100 metres from his residence in the Achan area of the south Kashmir district at around 11 am, police said, adding he was rushed to a hospital by passersby but succumbed to injuries.

His colleagues said that Sharma was not reporting late to duty following an earlier spate

of terror attacks on his community members. "Terrorists fired upon one civilian from minority, namely Sanjay Sharma S/O Kashinath Sharma R/O Achan Pulwama, while on the way to a local market," the Kashmir Zone police said on Twitter.

Deputy inspector general (DIG), South Kashmir Range, Rayees Bhat, said it was a "planned attack". He said armed security guards had been placed on duty in the village. "We had security in place here as well. Under what circumstances this attack took place is a matter of investigation. We will proceed further based on what comes out of these investigations," he added.

"We are sifting through the information that we have received so far. The terrorists involved in this crime will soon be tracked down and neutralized. We will not allow the terrorists to succeed in their evil designs," the DIG said. It was the first attack on a member of the minority community in Kashmir this year. Last year, terrorists carried out nearly 30 attacks on civilians, killing 18 people, including three Kashmiri Pandits, a bank manager from Rajasthan, a woman teacher from Jammu and eight non-local workers. Political parties have condemned the killing.

#### Kashmiri Pandit's Killing Sparks Outrage.

The targeted killing of yet another Kashmiri Pandit in south Kashmir's Pulwama district triggered a fresh round of protests in the union territory. Hundreds of Kashmiris turned out for the last rites of Sanjay Sharma. "I do not want to stay here. I fear that they will kill me too. Then where will my three young children go? Who is going to take care of us now?" Sharma's wife, Sunita, asked. Sunday's killing was the latest in a series of attacks on civilians and members of the Pandit community, prompting them to leave their homes.

# Letter to Editor

Often, in the fields of art, science, academics, creativity, and areas of research, ideas and concepts can be protected by the copyright laws. That, however, may not be true about a political thought or a strategy that may have important implications for a community in distress.

The recent "Ambala Declaration" viz-a-viz a plea by the AIKS, seeking "Minority Space for the Kashmiri Pandits in the Valley" appears to be one such proposition that has its genesis going back more than two decades. Many well-known leadership faces of the community representing several organisations across the board have pleaded with the Home Ministry and the National Commission for the Minorities in the past to grant our exiled community a minority status though without success.

Also, anyone reading the accompanying article in the February edition of NAAD, "Majority among the Minority - Claiming our Identity," by a contributor to the magazine pages would likely conclude that the "Ambala Declaration" isn't after all that novel an idea as it has been portrayed.

As is well known, it was conceived decades ago and even rearticulated yet again in 2014 as we learn from the present contributor's blog post reproduced in the magazine. All these concerted attempts made previously over several years, however, failed to impress any serious consideration with the authorities.

Timing is everything, and as the above article suggests, the best time to press for a minority status would have been as a supplement to the demand for the abrogation of Article 370. Did we lose a golden opportunity then? Or, do we still have a chance now when all our avenues to redeem our place in Kashmir have been shut by a series of decisions by the Supreme Court? Only the time will tell.

However, one thing is clear that no single person or a community organization, least among them the AIKS, can claim to be the architect of this political strategy, should someday the community attain the minority status. In all fairness, it can only be an outcome of the relentless persuasion by many selfless individuals by way of their personal effort or as community push at the organizational level. AIKS's political positioning now with this idea is too late for a Guinness Book entry.

#### DU to Set up Cluster Colleges to Function as Knowledge Networks

The University of Delhi (DU) will establish cluster colleges as knowledge networks. The university implements the National Education Policy 2020 (NEP) through the Undergraduate Curriculum Framework 2022 (UGCF). (The UGCF provides the curriculum framework with an FYUP.) The university will form cluster colleges to offer flexibility for students to choose the courses according to their interests and future prospects. Colleges of the university in the cluster will share their resources to the extent possible with other colleges in its vicinity to provide more choices to students and overcome the resource constraints and limitations at the end of each college, as per a DU statement.

While announcing the creation of clusters, DU said that university colleges would be grouped under five different cluster colleges depending upon their geographical locations, and each cluster college would operate as Knowledge Network. The college highlighted within a cluster has been identified as the nodal or hub college, which will act as the nodal point for coordination with the university and the colleges within the cluster for smooth implementation of the NEP. The nodal or the hub college will coordinate with the rest of the colleges in the cluster for effective and smooth networking for sharing of resources. Each college will have one nodal faculty to coordinate with the nodal or Hub College in a cluster or knowledge network. The coordinators of the nodal college and Co-hub College will coordinate with the nodal faculties in the cluster or knowledge network to constitute three working groups, Skill Enhancement Courses Working Group, Value Addition Courses Working Group and Ability Enhancement Courses Working Group.

#### Eligibility Criteria for Admission to NITs, IIITs, and CFTIs Revised

Following a meeting in the Ministry of Education, NTA agreed to add a criterion allowing students who scored in the top 20% of their board exam to apply for admission based on their JEE Main score

for admission to NITs, IIITs, and CFTIs. It is a relief to students aspiring to appear for the Joint Entrance Examination (JEE) Main, apart from the eligibility criteria of scoring 75 per cent and above in the class 12 exam. Students from the top 20 percentile of all boards will be eligible for admission based on their JEE Main score.

As the JEE Advanced already has the same criterion, this part-relaxation will allow students to compete for seats across NIT. According to the National Testing Agency's (NTA) JEE Main information brochure, in addition to the candidate's All India Rank (AIR) in the national entrance test for engineering admissions, aspirants must also score 75 per cent or higher in class 12 to be eligible for admission. The criteria were suspended for three years due to the Covid pandemic.

#### AICTE's Concern on the

#### crisis of vacant seats in Engg Colleges

The government will work towards strengthening the core engineering courses and introduce "industry-relevant" disciplines in these colleges, All India Council for Technical Education (AICTE) chairperson TG Sitharam said. In an interview, the former IIT-Guwahati director, who took charge of India's technical education regulator last month, told Fareeha Iftikhar that there is a need to set up an "institutional system" for regular feedback to bridge the gap between academia and industry. According to the AICTE chief, the AICTE will focus on spearheading an industrial co-innovation network while concentrating on diverse research fields in cooperation with international institutions and research centres.

Many engineering seats across the country are going vacant every year. To address this, the AICTE will emphasize core engineering subjects more. The AICTE recommends adding "industryrelevant" disciplines to current colleges. In contrast to public health engineers, who work on issues like waste and water management and environmental health, communication and security engineers may, among other things, be responsible for safeguarding sensitive data from cyberattacks.

To ensure that students who graduate from academic institutions have the skills necessary for in-demand jobs, these institutions assess future skill requirements and modify content and pedagogy appropriately.




